

**RESOLUTION NO. 2022-31**

**A RESOLUTION OF THE CITY OF HURRICANE, A MUNICIPAL CORPORATION OF UTAH, ADOPTING A SCHEDULE OF FEES FOR SERVICES PROVIDED AND CHARGED FOR LAW ENFORCEMENT SERVICES**

**WHEREAS**, services are offered by the Hurricane City Police Department for oversized load escorts and security for private and public events;

**WHEREAS**, the Hurricane City Police Department is authorized to charge for its costs related to these services;

**WHEREAS**, pursuant to Rule R909-2-17 of the Utah Administrative Code, all costs for certified police escorts of oversized loads shall be assumed by the permittee;

**WHEREAS**, the Hurricane City Police Department’s costs to provide oversized load escorts and security for private and public events have increased as a result of increases in wages, benefit expenses, and administrative fees;

**WHEREAS**, City Council has determined the fees included in this Resolution are appropriate and are reasonably related to the purpose for which such fees are charged.

**BE IT RESOLVED**, by the Mayor and City Council of the City of Hurricane that the following fees shall apply to the City Police Department:

<b>Description of Fee</b>	<b>Fee Amount</b>
Oversize Load Escort Service Fees	\$600.00 for first two (2) hours, plus \$100.00 per hour per officer for each additional hour, with partial hours being rounded up to the nearest one-fourth (1/4) hour.
Security Service Fees for Public or Private Events	\$100.00 per hour per officer, with partial hours being rounded up to the nearest one-fourth (1/4) hour.

The fees set forth in this Resolution shall become effective the 1<sup>st</sup> day of July, 2022.
